John Holt (1983-1985) is the author of *How Children Learn* and *How Children Fail*, which together have sold over a million and a half copies, and eight other books about children and learning. The magazine he founded, *Growing Without Schooling* (GWS), reflects his philosophy, which he called unschooling.
